ORDER:

In his letter fourth read above, the Chairman cum Managing Trustee, Aarthi Educational & Charitable Trust, Tiruchengode, Namakkal District has requested the Government to grant permission to start D.Pharm course at K.S.Rangasamy College of Pharmacy, Namakkal District with 60 (sixty) seats from the academic year 2023-2024.

2. In the Government letter fifth read above, the Director of Medical Education and Research was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education and Research has constituted an inspection team to verify as to whether the proposed Pharmacy college has fulfilled the conditions prescribed by Pharmacy Council of India, New Delhi and Government in the Government Order first to third read above.

3. In the letter sixth read above, the Director of Medical Education and Research has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant

permission to the Aarathi Educational & Charitable Trust, Tiruchengode, Namakkal District to start two years course in Diploma of Pharmacy (D.Pharm) with 60 (sixty) seats at K.S.Rangasamy College of Pharmacy, Namakkal District from the academic year 2023-2024.

4. The Government have examined the request in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and Research and decided to accept the same. Accordingly, the Government hereby grant permission to the Chairman cum Managing Trustee, Aarathi Educational & Charitable Trust, Tiruchengode, Namakkal District to start two years course in Diploma in Pharmacy (D.Pharm) with 60 (sixty) seats at K.S.Rangasamy College of Pharmacy, K.S.R.Kalvi Nagar, Tiruchengode, Namakkal District in S.F.No.208/1A-0.195 Acres, 207/1A-1.88 Acres, 207/1B1A-1.186 Acres, 207/1B2A-071 Acres and 212/2C-0714 Acres and measuring about 4.685 Acres with an annual intake of 60 seats from the academic year 2024-2025, subject to fulfillment of the infrastructure facilities and the general conditions laid down in G.O (Ms) No.148, Health and Family Welfare (PME) Department, dated: 24.04.2018 as applicable to this proposal before admitting the students, subject to the condition that the name in the Registration Certificate of the vehicle TN-33-J-5434 and TN-28-S-2377 will be changed to "K.S.Rangasamy College of Pharmacy" within three months of issue of the Government Order.

5. The Director of Medical Education and Research is directed to take necessary further action accordingly.
